RULES AND REGULATIONS:

1. **EXHIBITOR PASSES.** Two weekend passes with each paid 10x10 area at regular price will be supplied at move-in. You may leave passes at the show office for your staff. No one will be allowed entry to show without a pass.

2. **Additional passes can be purchased at move-in at a reduced cost.**

3. **EXHIBIT SPACE ALLOCATION** will be assigned by show management according to the date the application for space was received. All contracted fees must be paid in full before move-in will be allowed. The **DISTRIBUTION** of handouts, flyers, coupons, literature and/or samples are restricted to your assigned exhibit area only, unless approved in writing by show management. **SUBLETTING** of space will not be allowed unless prior written approval has been attained from show management.

4. **DECORATION** limited to your assigned exhibit area only. Nails, hooks, tacks, screws, or tape of any such kind in/on the walls or floors of the building. Each exhibitor is responsible for any damage caused by any person associated with its business or display, including volunteers. **DISPLAY FIXTURES** are not provided unless ordered through show management or the contracted services company. (See Show Services Rate form)

5. **ELECTRICAL POWER** - ordered at the time of contract from NES Electrical 604-469-2726

6. **OPERATION OF EXHIBITS** are to be between all open hours of the show. An exhibit with no staff is your own responsibility. **LOUD SPEAKERS** and/or **EQUIPMENT** operating in such volumes as to annoy other exhibitors will not be tolerated.

7. **GENERAL BEHAVIOUR.** If for any reason an exhibitor/exhibit is deemed objectionable by show management, the exhibit or persons will be subject to removal from the show. In the event of such an eviction being enforced, the show management will not be liable for any refunding of any type to the exhibitor or company that is represented. Good behaviour is mandatory.

8. **FIRE REGULATIONS.** Exhibitors must conform to all building, local, city, provincial, and federal laws, ordinances and regulations in respect to fire, safety, health, and all other matters. All exhibit equipment and materials will be reasonable located and protected by safeguards and devices where necessary. Only fireproof materials shall be used in displays and the necessary fire precautions will be taken in regards to vehicles. Gas tanks are to have less than 1/4 tank of fuel and gas caps are required to be locked or taped. Batteries are to be disconnected. PROPANE bottles - capacity cannot exceed 5 pounds and must conform to all other policies and procedures of the facility.

9. **SECURITY** guards will be on duty throughout the night. However, show management, directors, staff, or its volunteers will not be held responsible for damage or theft.

10. **INSURANCE.** Exhibitors must have liability insurance. Please contact your insurance agent and ensure that you are adequately covered during the dates of the show, including move-in and move-out.

11. **INABILITY TO PERFORM.** If the show management should be prevented from holding the show by any cause beyond its control or of it cannot permit the exhibitors to occupy the rental space due to circumstances beyond its control including, but not limited to strike, fire, civil disobedience, inclement weather, lockout, acts of God, the show management will refund to the exhibitor the amount of the space rental paid only, to a proportionate share of the shows expenses to that point, and show management, its directors, management, staff and volunteers of any kind, shall have no further obligations or liabilities to the exhibitor.

12. **LIABILITY.** Neither the **AUCTIONEER COMPANY** on site, **Backseat Promotions Ltd.**, its directors, representatives, management, staff employees, volunteers of any kind of the show will be responsible for injury, loss or damage from any cause whatsoever that may be suffered by an exhibitor, employees, or property. It is agreed by the parties that the nature of the facility available, the presence and circulation of large number of removable articles in the numerous exhibits, and various other factors make it reasonable that each exhibitor shall assume the risk of injury, loss or damage and that the exhibitor in signing this contract thereby assumes such risk and expressly released the organizations and individuals referred to above from any and all claims for such injury, loss and damage. Exhibitors wishing to insure their own goods must do so at their own expense.

13. **MOVE-OUT** to be done promptly and carefully. Each exhibitor is responsible for the removal of all display materials brought into the building. Extra clean up charged brought against show management will be passed on to the exhibitors involved. Everything must be removed at the designated times or storage and removal costs are subject to be charged to the appropriate exhibitor. **PLEASE NOTE: TEAR DOWN AND REMOVAL OF BOOTHS WILL NOT BE PERMITTED UNTIL 6PM SUNDAY OR AWARDS CEREMONY IS COMPLETED.**
